## **POSITION SUMMARY:**

Reporting to the Manager of Tobacco Control, the Youth Engagement Facilitator will actively engage youth in taking action to address changing individual and community attitudes towards tobacco use and de-normalizing the tobacco industry and its products.

### **DUTIES AND RESPONSIBILITIES:**

#### **Program:**

- Working with youth, the community at large and the Youth Engagement Specialist, the Youth Engagement Facilitator will:
  - Engage and facilitate Smoke-Free Ontario-funded youth programs in tobacco control both internally and with external youth focused organizations
  - Implement youth led community-based tobacco-focused programming and projects that will benefit the public and its health by contributing to the reduction of tobacco use and the reduction of other highly correlated risk factors, including cessation efforts amongst youth and young adults
  - Facilitate the integration of tobacco use reduction/control efforts with other mandatory
    Ontario Public Health Standards (O.P.H.S.) programs as appropriate
  - Work collaboratively with the Youth Engagement Specialist to develop, plan and implement regional action plans, including the establishment of a Regional Youth Engagement Coalition
  - Ensure that tobacco use reduction/control related training needs are identified and addressed
  - Participate in regional Tobacco Control Area Network (TCAN) structures, and collaborate on the planning and implementation of joint activities
  - Work with resource centres (eg. OTRU, YATI and PTCC) to assist in the development of learning experiences that will enhance community effectiveness regarding tobacco control

Position Description: Youth Engagement Facilitator

- Assist in the coordination, development and implementation of tobacco control policies and youth programming within the TBDHU, and facilitate the integration of tobacco control efforts within other Ontario Public Health Standards (O.P.H.S.) programs
- Ensure that Smoke Free Ontario activities are carried out in the community in a planned and coordinated manner that maximizes utilization of resources
- Develop and facilitate the adoption of policies and the support implementation of policies and/or practices to reduce or eliminate exposure to second-hand smoke in public and private places

- 1. Post Secondary Education from a college or university in health, social services or a related field
- 2. Experience working with youth
- 3. Ability to lead youth and supporters towards a stated objective
